Co-op meets with local legislators

Every fall, MiEnergy hosts a state legislative meeting at our cooperative offices with our locally-elected officials to review the last legislative session and to address the upcoming session. On October 12, Senator Miller and representatives Davids and Pelowski attended the Minnesota meeting in Rushford. On October 19, Senator Klimesh and Representative Bergan attended our meeting in Cresco. Our focus during these meetings was reliability, affordability and sustainability.

MiEnergy meets and communicates with all our elected officials throughout the year and consistently when the legislatures are in session. Thankfully, we have received tremendous support from our local elected officials. Whether Democrat or Republican, they are all champions of MiEnergy and supporters of electric cooperatives.

In fact, in July 2023, MiEnergy and a dozen electric cooperatives in Minnesota appealed our property tax valuation from the Minnesota Department of Revenue's reinterpretation of a 1939 state statute on "attachments and appurtenances" that added a tax on streetlights and electric meters on electric distribution lines. This reinterpretation increased our property tax valuation by millions of dollars. MiEnergy filed an appeal and invited representatives Pelowski, Davids, and Senator Miller to our virtual hearing. With our facts, calculations and the support of our elected officials, we successfully lowered our valuation below the previous year.

For 2024, property taxes are one of our Minnesota legislative priorities. With the help of our elected

officials, we will be introducing legislation to clarify the misinterpretation by the Minnesota Department of Revenue to avoid future challenges. Permitting new generation resources - including solar; increased Department of Natural Resources fees for crossing and timber management fees; education on repealing Minnesota's nuclear moratorium for future small modular reactor applications; and concern for new energy industry mandates round out our 2024 Minnesota issues.

For Iowa, utility-scale solar setbacks will likely resurface. Electric cooperatives believe local cities, townships and counties should determine these issues, and we do not support a state law - one size fits all - on setbacks on utilityscale solar projects. Electric cooperatives are "neutral" on carbon pipeline legislation. While we support ethanol and the industry, we do not want our electric distribution and transmission lines to be lumped into the same regulatory requirements as carbon pipelines. MiEnergy is also concerned about potential legislation being introduced regarding a recent farm organization survey about overhead line clearance above the requirements of the National Electrical Safety Code (NESC).

During our legislative meetings, we communicated that Dairyland Power Cooperative, our wholesale power provider, and MiEnergy set new historical system peaks on August 23. MiEnergy's peak occurred at 8 p.m. and exceeded the previous peak by nearly 10%. Maintaining baseload generation units and natural gas peaking units will be critical for maintaining system reliability during our country's energy transformation to become carbon-free.

MiEnergy also took the opportunity to highlight a federal Powering Affordable Clean Energy (PACE) program application to install an additional 5 megawatts (MW) of utility-scale solar on our distribution system. MiEnergy's application is a joint effort by 14 electric distribution cooperatives who are members of Dairyland Power Cooperative to install over 80 MW of solar generation.

Through the years, MiEnergy has built very positive relations with all our elected officials. Representatives Pelowski and Davids are the two longest-tenured representatives in the Minnesota legislature, and it's reassuring that all our legislators support and carry the legislation that supports our electric cooperative.

Members give \$5,000 in local donations

MiEnergy Cooperative's Operation Round Up Trust Board met in September and elected to donate \$5,000 to the following local organizations:

• \$2,000, Fillmore County Ag Society, Preston, Minn., to

- \$1,500, City of Spring Grove, Spring Grove, Minn., to purchase automated external defibrillators.

Serving up savings for the holidays

Be festive without breaking the bank

- LED holiday lights use 88% less energy than incandescent ones, plus they are shatterproof.
- Use smart light timers connected to a smart phone app to program lights to turn on and off at certain times.
- Turn off overhead lights and use your Christmas tree lights to illuminate the room.
- Close the flue of the fireplace when you are not burning a fire to keep heat from escaping through the chimney.

Cook up savings in the kitchen

- Use small countertop appliances like microwaves, air fryers and slow cookers instead of a stovetop or oven.

APPLE SALAD | RHODA REIFF, RICEVILLE

2 yellow apples 2 red apples ¹/₄ c. peanut butter 1 c. whipped cream

Dice apples. Mix whipped cream and peanut butter. Pour mixture over apples and toss. Refrigerate until cool or serve immediately.

PEACH CRISP **DIANA NESS. WAUKON**

4 c. peaches (pealed and chopped) 1 c. sugar 2 T. Flour Stir together and pour in bottom of 9x13" baking pan.

Mix crumble as follows: 1 c. flour 1 c. brown sugar 1 c. quick oats 1 stick butter (softened)

Mix together and spread on peach mix. Bake at 350° for 35-40 minutes.

4 WAYS TO SAFEGUARD SAFETY **YOUR HOME** FIRST THIS WINTER

- Ensure carbon monoxide and smoke detectors are working properly. Test once a month and replace batteries annually.
- Inspect electrical cords. Double-check for frays and cracks. Never plug a space heater into a power strip.
- Avoid overloading electrical outlets and power strips. Make sure strips can handle the electric load and choose ones that include surge protection.
- Clean the fireplace and chimney to improve safety and efficiency. Creosote builds up Regular cleaning improves airflow and limits carbon monoxide seepage.

TURTLE PECAN BARS | JESSICA HEBERLEIN, CALEDONIA

1 pkg. graham crackers 2 c. dark chocolate chips 1 c. salted butter

1 c. brown sugar 1 c. chopped pecans

Preheat oven to 350° F. Line a 9x13" pan with parchment paper. Place graham cracker sheets along the bottom of the pan, ensuring the bottom of the pan is covered. Add butter to a large saucepan over medium heat and allow it to melt. Add the brown sugar and pecans, and stir constantly, bringing the mixture to a full boil. Boil for 3 minutes. stirring constantly. Remove from heat and pour mixture over graham crackers and spread into an even layer. Bake for 4 minutes. While the bars are baking, in a small sauce pan, melt chocolate chips on low, stirring frequently. Remove bars from oven, and cool for 5 minutes. Carefully spread melted chocolate over the top of the bars. Allow to cool completely before serving.

TEXAS ICE BOX FRUIT CAKE **EILEEN MENSINK. PRESTON**

1 lb. graham crackers 1 lb. dates 1 lb. pecans 1 lb. marshmallows 4 T. brown sugar

9 t. vanilla 1/2 lb. candied cherries 1/2 lb. candied pineapple 1 lb. butter

Melt butter and marshmallows together; add brown sugar and vanilla. Stir crushed cracker crumbs, candied fruit and nuts into butter-marshmallow mix. Mix well. Shape into rolls and wrap in waxed paper. Refrigerate. Slice rolls to serve. Can use 1 lb. of cherries and pineapple and be sure to use butter, margarine just doesn't work. There are a lot of slices in this recipe.

MINNESOTA MEMBERS NOTICES

MILITARY PERSONNEL ASSISTANCE LAW

When a household member has been ordered into active duty for deployment or for a change of duty station, some members may find it hard to pay their utility bills. Minnesota Law protects military personnel from shut-off if they cannot pay their bill when certain conditions are met. For more information, visit www.MiEnergy.coop or call 800-432-2285.

ELECTRIC HEAT SALES TAX EXEMPTION

Electricity sold for residential use is not taxable for the billing months of November through April when sold to metered customers in Minnesota who use it as their primary source of residential heat according to Minnesota law. If more than one type of heat is used, electricity is not taxable if it is the primary source of heat. Primary source of residential heat is the source that supplies more heat than any other sources for the largest period of time during the heating season.

If your property has both residential and commercial operations and only one meter for the entire building for electricity, square footage is used to determine if the residential exemption applies and is determined if more than 50 percent of the square footage of the building is residential.

If you have filed an exemption card with us in the past, you do not need to file again. If your electric heat is used in conjunction with wood or another fossil fuel, please re-evaluate your heat status.

Members who receive a tax exemption when electric heat is NOT the primary source of heating are in violation of the Minnesota law. Please contact us if your heating has changed and you should be taken off the tax exemption as it is your responsibility to notify us of any changes when you are no longer eligible.
