

OFFICIAL NOTICE OF RATE CHANGE FOR MAY 1, 2025

This document is an Official Notice that includes specific legal language and information for members about a change in electricity rate tariffs.

On February 27, 2025, the MiEnergy Cooperative Board of Directors approved a change in the electric rate tariffs. **There has been no change made to the kilowatt-hour (kWh) rates, however the basic service charges and kilowatt demand (kW) rates have increased.** These changes will be applied beginning May 1, 2025, and be reflected on the statement you receive in June.

The rate change in May will result in an annual revenue increase of 3% for the cooperative based on historical energy sales. The last rate change for members in 2023 resulted in an annual revenue increase to the cooperative of 5% based on historical energy sales.

The impact of the rate change on your bill will vary depending on your rate class. The new rate tariffs are listed below.
